To Answer a Call

• Lift Handset, Press Speaker or Line

To Place a Call

• Lift Handset or Press Speaker Button, Dial extension or 9 + ten digit number

To Place a Call to ACH 449 Numbers

• Dial *7 plus last 4 digits

To Place Call on Hold

• While on a call, Press Hold (soft key) To retrieve call, press Resume

To Transfer a Caller

- Press Transf softkey
- Dial number (Announce the call)
- Press *Transf* softkey or Hang up.

To Create a Conference Call (up to 6 participants)

- Press *More* softkey to get to additional features
- Press Confrn
- Dial Number and announce conference call
- Press *Confrn*

To Park a call (while on a call)

- Press *More* softkey to get to additional features
- Press *Park* (Note Park number on display)

To retrieve Parked call

• Lift handset and dial displayed Park Code

Call Pickup

- Lift handset and Press *More* softkey to get to additional features
- Press *Pickup* softkey
- Press Answer

Join Command:

- On the active line, hit the *More* softkey twice until you see the *Join* command. Press *Join*.
- Use the arrow key to move to the line on hold, once this is highlighted, press the *More* softkey, and the *Join*.

Call Forward

- Press *CfwdAll* softkey
- Press Messages (to voicemail) or enter an extension or 9+ Number if allowed

Change Phone Settings

- Press the Setting Button
- Select User Preferences
 - Select Rings
 - Select Background Images

Send an incoming call to Voicemail

• Press *iDivert* while call is ringing

To Set Up Mailbox

- Press Messages Button
- Enter Default Password (<u>112233</u>) followed by #
- Follow voice prompts to record Name and Greeting
- Change Password (Must be 6 numbers long.)

To Access Voicemail

- Press Messages Button
- Enter Password followed by #

To Leave a Message in Voicemail

- Press *, Dial extension
- To by-pass Greeting, Press #.

To Skip a Message in Voicemail

• Press "#" to skip a message in your Voice-mail

To transfer a caller directly into Voicemail

- Press *Transf* softkey
- Dial *, then extension number
- Press *Transf* softkey or hang up

To Access Your Mailbox remotely

• Dial your Direct Dial Number, when greeting starts, press * then enter your ID (Extension number) followed by # and Password followed by #. Or Dial the Back Door Number (280-2500) and enter ID and Password.

Cisco Unity Voicemail

The key to effectively using Cisco Unity voicemail is to realize voicemail is also email. The message is stored as an email and has a *.wav file attachment that contains the audible message. Messages can be retrieved by two methods; via the phone or playback from email. Your computer must be equipped for audio to listen to messages.

Message retrieval from email is done by opening the message and double-clicking the *.wav file.

NOTE: Because voicemail is also email, actions performed to one will directly affect the other.

- Unread/Read vs. New/Saved messages When an email message arrives, it is an unread message. This is depicted by the message being bold faced in the message list. Similarly, when a new voicemail arrives, it is a new message. This is indicated by a <u>Message Waiting Indicator</u> (MWI) on the phone the red light, and when you log into voicemail you will hear the greeting "you have new messages!" Since voicemail is email, if the email status changes from unread to read, the voicemail status changes from new to saved. Therefore, once the email message is opened or viewed, the MWI on the phone will turn off and the system will say "you have no new messages." If you change the status of an old message to unread, the MWI will turn on and the prompt will indicate new messages.
- Moving voicemail out of your Inbox will make it inaccessible via phone Cisco Unity Voicemail does not look in other mail folders for messages. If you move messages out of your inbox, you can no longer listen to them from the phone. The same is true if a mail filter or rule, junk-mail filter, or other setting moves the message. Your message will still be received via email, but the MWI and new message prompt will not indicate new voicemail.
- **Deleting Messages** If you delete a message in Outlook, it is moved to your Deleted Items folder. This message can still be retrieved until the Deleted Items folder is emptied. If a message is deleted using the phone, it is **permanently deleted** and cannot be retrieved.
- Outlook Web Access, Mobile Devices, or a Blackberry, Actions performed using any of these devices to your messages will affect their status in Outlook. If you open a message, the status will change to read, your MWI will not light, and you will not receive the new message greeting if you call into voicemail.

NOTE: Depending on the system load the MWI does not always change instantaneously.
